- 1. This has reference to inaccurate disclosure, displaying products related to industrial gases including oxygen, on your website despite discontinuation of manufacturing and supply of industrial gases since August 1, 2019. Further, the Company received NBFC Registration certificate dated December 31,2019 from the Reserve Bank of India on January 7,2020.
- 2. Accordingly, the company should have updated the website immediately to reflect the aforementioned changes. It is noted that the Company has updated its website only after BSE highlighting the discrepancy on May 20,2021.
- 3. As per Regulation 4(1)(c) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("LODR"), a listed entity should refrain from misrepresentation and ensure that the information provided to recognised stock exchange(s) and investors is not misleading.
- 4. The aforementioned observations point to non-compliance with the provisions of the LODR Regulations by the Company. The same is viewed seriously and you are hereby warned for the failure in ensuring compliance with applicable regulatory provisions. You are also advised to ensure timely compliance with all applicable provisions of law in future.
- 5. Further, it is advised to place this letter before the board of directors of the Company and to disseminate the same to the stock exchanges immediately
